

Data protection of personal data information processed by the Hungarian Helsinki Committee in connection with the webinar *Access to classified data in national security immigration cases* to be held on 17 October 2024

The purpose of the information below is to help you find out all important information related to the processing of your personal data by the Hungarian Helsinki Committee (HHC, hereinafter: the Association) in connection with the event indicated in the title.

We handle personal information about you

The protection of individuals with regard to the processing of personal data and on the free movement of such data is covered by the European Parliament and the European Council with (EU) Regulation 2016/679 (17 April 2016) hereinafter referred to as the GDPR. The regulation is supported by Act CXII of 2011 on the Right of Informational Self-Determination and Freedom of Information (hereinafter: 'Infotv').

Processing of your personal information is made possible if you give your consent under Article 6 (1) of the GDPR. We will ensure that all data processed about you will be protected in accordance with the guarantees that GDPR sets out for the processing of special data.

What data do we handle and why?

The Association collects the following personal data:

- a) name;
- b) email address as contact information; and
- c) a portrait photo taken at the event.

The purpose of data management is for the Association to comply with accounting and audit regulations that oversee our activities.

The **legal basis for data processing** is that you have given consent to the processing of your personal data [GDPR Article 6 (1) (a)] and that the activities of the Association during a donor audit [Article 6 (1) (c) GDPR] can be reported, and that in the case of possible donor claims, the legitimate interest of the Association is to be able to prove the provision of the service [Article 6 (1) (f) GDPR].

Who has access to your data?

The **Data Controller** for the recorded data is the Hungarian Helsinki Committee (headquarters: 1074 Budapest, Dohány u. 20. II/9, email address: helsinki@helsinki.hu, Tel: 06-1-321-4141; contact of the Data Protection Officer: helsinki@helsinki.hu). Your data can be accessed by the Association's accountant, or in the case of any audit, by the employees of the organisation performing the audit.

The managed data can also be accessed by the co-presidents of the Association, the employee responsible for finances, the project manager and the current accountant. The data may not be disclosed to anyone else in any form without your expressed prior consent.

What organisational and security measures do we take to protect your data?

Only the people listed above will have access to your information. We store your data on our own server or on paper.

How long do we handle your data?

The Association will process your personal data until the withdrawal of your consent, but no later than five years from the date of the conference. The data will also be kept for five years in the event of withdrawal of consent in accordance with GDPR Article 6 (1) (c) and (f) in order to be able to prove the conference participants during an audit.

If, at the end of the above deadlines, a legal proceeding is initiated by you or by others, during which the processing of the data by the Association is still necessary in order to submit, validate or protect the claims of the Hungarian Helsinki Committee, the deletion of the data will take place after the case is concluded.

Can you request the deletion, correction or restriction of data processing?

You may request the deletion of your data and contact details collected for your donation if you consider that the processing is unlawful, no longer necessary for the purposes for which it was processed, or if the data must be deleted under an EU or Member State legal obligation.

Of course, if data has been incorrectly recorded or there has been a change in your data, you can request the **correction** of the processed data.

You may **object** to the processing of the data after the service has been provided, in which case your data will be deleted unless we can prove that the processing is justified by compelling legitimate reasons which take precedence over your interests, rights or which are connected to submission, exercise or defence of legal claims.

How do you access information about your personal information and what legal recourse do you have?

You may request **information** from the Association as to which personal data we process, for what purpose and in what way. You may also request a copy of the personal data we processed. We will fulfill these requests free of charge.

In order to protect your data, we can only grant your rights of access after prior **proper identification**. Therefore, we request that you submit your requests, statements or complaints related to data management in writing. If this is not possible for any reason, please call the Association at +36-1-321-41-41. In the latter case, proof of identity will be required to exercise your rights.

You may also file an action for the unlawful processing of your personal data or the violation of your rights to information self-determination with the **Metropolitan Court** (Markó u. 27, 1055 Budapest, Hungary. Mailing address: 1363 Bp. Pf. 16.) or with the competent court according to your place of residence, or turn to the **National Authority for Data Protection and Freedom of Information** (Falk Miksa utca 9-11, 1055 Budapest, www.naih.hu).
