



## Family Reunification Handbook for People with International Protection

### 1. Who can bring their family members to Hungary?

- Refugees (menekült)
- People with subsidiary protection (*oltalmazott státusz* – 5 years protection)

### 2. Which family members can join you in Hungary?

The following family members can join you, if you can prove that you are related:

- Your spouse (wife or husband, and family reunification is limited to the first spouse);
- Your minor child (children under age 18), including adopted and foster children;
- Your minor child (including adopted and foster children) if you have parental custody and the child is dependent on you;
- The minor child (including adopted and foster children) of your spouse, if your spouse has parental custody and the child is dependent on your spouse;
- your adult children (over age 18), if they cannot care for themselves due to health problems (e.g. serious trauma, serious injuries suffered in bombings) - If you were granted the full refugee status,;
- Your parents, or your guardian by law, if you are under the age of 18 when your parents apply to come. Your guardian by

law can be anybody who can legally represent you (relatives or persons based on law);

- Your parents, if they cannot pay for their cost of living in their country of origin - if you were granted the full refugee status and if you are older than 18 and your parents depend on you financially;
- your brother/sister, if they cannot care for themselves due to health problems - if you were granted the refugee status,;
- your grandparents/grandchildren, if they cannot care for themselves due to health problems - If you were granted the full refugee status,.

**Important!** Your spouse can only join you, if you got married **before you came to Hungary**.

*If you need to prove that your family members **cannot take care of themselves** due to health problems, you need to prove this with a doctor's written opinion.*

### 3. How can you prove that you are related to your family members?

You will need to prove your family links and can do so with the following:

1. birth certificate;

2. marriage certificate;
3. adoption document;
4. any other official document or statement which verifies the existence of the family tie (eg. photos about your wedding);
5. DNA test (Please note this costs around 200-400 EUR).

The Office of Immigration and Nationality (OIN – in Hungarian: *Bevándorlási és Állampolgársági Hivatal, BÁH* www.bmbah.hu) will ask two things regarding these documents (birth certificate, marriage certificate, ID-card)

- **(i) Diplomatic stamp:** The stamp certifies that the original certificate presented by the family member is a genuine one and not fake. It is issued by the Ministry of Foreign Affairs or an Embassy of the country of origin if the family members are abroad. In order to get this, your family member must first get a certifying stamp from their Ministry of Foreign Affairs (in their home country) on the certificates. Secondly, your family member should ask the Hungarian Consulate to certify the document with a diplomatic stamp.

**Important!** *If it is absolutely impossible or dangerous for your family member to contact their Ministry of Foreign Affairs to certify their documents, you should inform OIN about these risks.*

- **(ii) Certified Hungarian translation of certificates and documents.** In Hungary, only the Office for Translation and Attestation Ltd. (OFFI Ltd.) can provide the foreign documents with a certified translation. In this case only the original document is certified here

and not the copy. If somebody else already translated your documents into Hungarian, the OFFI can also check this translation and certify that. You have to pay OFFI for the certified translation, but if OFFI only checks the translation, that is cheaper than OFFI translating the whole document. If you cannot pay for the OFFI translation, inform OIN about this and make sure you ask another 'non official' translator to translate your documents.

**Important!** *According to Act II of 2007 on the Entry and Stay of Third-Country Nationals (19. § (3)): a decision **rejecting an application** for family reunification with a person with refugee status **may not be based solely on the fact that documentary evidence of the family relationship is lacking.***

*This means, that if you are a refugee in Hungary and you do not have a marriage/birth certificate but you can verify the family relation (set out in Question 3) and every other condition is fulfilled, OIN cannot reject the application only for the lack of documentary evidence.*

#### 4. When should you apply to bring your family?

If you get your refugee status, and you want to bring your family members to Hungary, it is very important, that your family members start the process as soon as possible.

**If you received** a refugee status, and your family members apply for the visa **within 6 months** of the date of your refugee status, you do not have to meet the criteria listed in Question 5. A, B, C: enough money to cover

costs of living, a big enough flat and full health insurance. The 6 months period starts on the day when you were informed about the refugee status granted to you (it can be 1-4 weeks later than the date of your decision.)

#### 5. What do you have to prove to bring your family members to Hungary?

If you received your refugee status more than 6 months ago, or if you have subsidiary protection you must provide proof of the following:

- a) **Enough money**<sup>1</sup> to cover the costs of living of the family members, proven by the following (any of them):
  - money in Hungarian Forint or money in other currencies (that can be exchanged in a Hungarian bank);
  - deposit book or other documents from the bank and a statement from the bank that the money is available;
  - checks, credit cards and a statement from the credit institution to certify the availability of funds;
  - official invitation letter;
  - documents that prove you rent a flat and that you paid for it; proof of your income from lawful employment in Hungary;
  - proof of regular income from abroad;
  - your notarized statement that you will provide support to your family member;
  - other reliable means.

OIN will decide after considering every relevant factor in your case. While OIN is also considering humanitarian grounds, the most important factor will be the financial one.

#### b) A big enough flat for the family members to live in

<sup>1</sup> Please note, that the amount of money indicated by the Hungarian Statistical Office is not the only basis of a decision.

'Big enough' means, that there are 6 square meters of living space for every family member.

For example, if you want to bring your spouse and 3 children, you are a family of 5 people. This means, you need to live in a flat where the living/sleeping room area adds up to 30 square metres.

**Important!** *You do not have to own a flat, it is enough that you are legally staying in a flat (renting it or using it for free).*

You legally stay in a flat if you have:

- a valid rental contract where you pay rent to the owner, with the written agreement of the owner that your family members can stay in the flat (*befogadó nyilatkozat*);
- a valid contract of courtesy which states that you do not pay rent to the owner for using the flat, and the written agreement of the owner that your family members can stay in the flat.

In addition to the lease contract, you need to prove to OIN that this flat is a real one. You can prove this with showing the property paper (*tulajdoni lap*) of the flat which proves that the flat exists and the person providing the written agreement is entitled to sign such agreement because s/he is the owner of the flat. The property paper needs to be shown to OIN in addition to the lease contract. Anybody can get the property paper of any flat from the local Land Registry Office (*Földhivatal*) and it costs around 7000 HUF.

#### c) Full health insurance in Hungary for the family members

In Hungary, the regulation requires you to arrange the full health insurance contracts for your family members before they come to Hungary. You can make OEP (*Országos Egészségügyi Pénztár*) health insurance contracts (state health insurance), or private ones. You can request help from Menedék Association to advise you how to make a

contract with the OEP or with other service provider. OIN may waive this requirement provided you can fulfil all of the following conditions:

- your family has enough money to cover the costs of living every month, and
- your family members have travel insurance, and
- you make a statement that after your family comes to Hungary, you will make full health insurance contracts for them.

OIN may allow this second possibility that your family members do not have to have full health insurance coverage before coming to Hungary - but is not obligated to do so.

#### **d) Enough money with family members for return travel**

Your family members will have to show that they have enough money for paying a ticket for their return to their country of origin. Refugees, whose family members apply within the 6 months do not have to prove this.

**Important!** *It is also very important, that your family members can only reunite with you in Hungary if they have valid passports (see Question 14.).*

#### **6. Can I reunite with my parents?**

Refugees (beneficiaries of subsidiary protection not included) who are over the age of 18, can bring their parents to Hungary if they prove that their parents are dependant on them.

You can prove this with the following:

- certification that they are not working. This certification can be issued by any state agency or officials who know the parents.
- certification that they are not getting a pension from their state;

- country information or common sense/general knowledge that old people are dependant on their relatives in some countries (for e.g. Afghanistan);
- country information which proves that there is no pension system in your parent's country. This can be any document issued by any local authority. This is usually obtained not by the lawyer, but by the family members.
- any other document, evidence which proves that your parent is dependant on you. This document can be a declaration of the family members themselves that the only person to support them is the refugee.

#### **7. How can I bring my sisters or brothers (siblings) to join me?**

If you are a refugee (full protection status) you may have the possibility of reunification with siblings who have health problems and **are unable to provide for themselves due to health reasons** in their country of origin. In practice, the burden of proof here is quite high. You can try to prove the health problems with the following:

- doctor's written opinion about the sibling's disease and its impact on their independent living;
- any written statement by a health professional (a person who is not a certified doctor but who has knowledge about health issues/diseases) about your sibling's treatment plan;
- You can request help from the International Committee of the Red Cross (ICRC) or another organisation to go and visit your sibling and obtain a doctor's opinion about your sister or brother. Please note, that the extent to which these organisations can help may depend on their country context and their local resources.

## 8. Who starts the family reunification process and where?

**Your family members must start the process** in the country where they are legally residing – if family members are not legally residing in the country, the Consul might refuse to take the application of the family member – and where a Hungarian Consulate issues visas. This means, that you cannot start the process in Hungary, but your family members have to go personally to a Hungarian consulate and start the process there (it is not possible to make an application via Post or electronically).

**Important!** *If your sister or brother wants to come to Hungary, and she/he is a minor (younger than 18), one of her/his parents, or legal guardians must also go to the consulate, and **the parent must sign the application form** instead of your sister/brother.*

*Your family members have to lodge the application for residence permit in person in the country where they reside or at the nearest Hungarian consulate.*

For the contacts and opening hours of some Hungarian Consulates, see Appendix 2.

## 9. How to complete the visa application form?

You can find the visa application form on the website of OIN in 4 languages (Hungarian, English, German).<sup>2</sup> The visa application form (see Appendix 1.) has to be handed in by your family member at the Hungarian Consulate (see Point 5.). However, you may wish to complete the form for them, and send the form to your family members by

fax, email or post. You can get help with completing the form at the Hungarian Helsinki Committee and Menedék Association.

Please note:

- the **applicant** is your family member;
- the **host family member of the applicant** is you.

If you are a refugee, and your family members apply for the visa within 6 months of the date when you got your refugee status, **you do not have to fill out** the following points in the visa application form:

- Data of costs of living in Hungary (Part 6.) (However, you will need to indicate your future address in Hungary on the application form);
- The first question in Part 10: For the period of the stay in Hungary do you have full health insurance?

## How to get an appointment with the Hungarian Consulate?

It is best for your family member to make an appointment at the Consulate before going there, to avoid being unable to lodge their application during busy periods. Even though every Consulate has office hours when they are normally open to take visa applications they are sometimes too busy to take applications for family reunion. Therefore, it is always better if your family member asks for an appointment from the Consulate before she/he goes there. If your family member goes to the Consulate without an appointment, it can happen that she/he cannot submit the visa application, and must go back to the consulate again.

At some consulates, it is possible to get an appointment through the Internet. If you cannot get an appointment on the Internet, you can also try to ask for an appointment by calling the Consulate. See the telephone numbers and websites of some Consulates in Appendix 2.

For the family members of those refugees whose refugee status was granted not longer than 6 months ago, it is very important to ask for an appointment from the Consulate as soon as possible. Some Consulates can only give an appointment in 1-2 months time, and your family may lose the chance to come to Hungary under the easier circumstances (see Question 4).

If your family member cannot ask for an appointment from the Consulate before she/he goes there, **your family member should still insist** that the Consulate takes her/his visa application form. By law, the Consulate is obliged to **take** the visa application.

#### 10. What if there is no Hungarian Consulate in the country where my family lives?

Very often, there are no Hungarian Consulates in the country which you had to leave or where your family is legally residing. For example, there are no Hungarian Consulates in Afghanistan, Syria, Somalia, Ethiopia, or Sri Lanka. If your family members need to travel to another country to visit a Consulate, they can ask for the help of the International Committee of the Red Cross (ICRC). However, ICRC cannot help in every region; it depends on their capacity.

#### 11. What happens at the Hungarian Consulate?

Your family members must hand in the following:

- completed visa application forms;
- the visa application fee (of 60 EUR for each person, adult or minor);
- passport photos (1 per family member);
- show their valid passport;
- show their valid visa with which they are legally staying in the country where the Hungarian Consulate is located.

**Important!** *The Consulate is obliged to take the visa application and start the process if your family members are legally staying in the country where the Hungarian Consulate is located, and they hand in the completed visa application forms, pay the visa application fee,*

The Consul must give back a receipt to your family member which proves that your family member paid for the visa application (60 EUR/person). Your family member may have a short interview at the Consulate about the reasons why they want to join you in Hungary. However, the practice of the Hungarian Consulates around the world differs: at some Consulates, family members are interviewed, at others they are not. If there is an interview, your family member **should ask for a copy of the written minutes of the interview**, and the Consulate is required to give him/her **this copy**.

Once the application is lodged, the Consul is obliged to forward the application to OIN in Budapest **immediately**.

#### 12. What happens after my family members submitted their application?

After OIN has received the visa application from the Hungarian Consulate, it makes a decision on the application within 21 days. If there are any documents missing, OIN will ask you to submit these documents (hiánypótlás) and OIN will set a deadline for this. If this deadline is too short to get the needed documents, and you need more time, you can ask OIN in writing to extend the deadline (*határidő-hosszabbítás iránti kérelem*).

After the Consul forwards the visa applications to OIN, your family member's visa application will receive a case number and a case officer. If you prove to OIN that you are the host family member, you can take part in the process by submitting any documents which support the family reunification case. You can call the case officer by telephone, or send letters with copies of the documents.

This is important, because you do not have to send any important documents to your family members, but instead you can send them directly to OIN.

OIN either accepts or rejects the visa applications.

If OIN accepts the application, this means, that your family members will get a residence permit for 1-3 years with a D-Visa. Your family members must travel to Hungary with this visa within 6 months/12 months (the validity of the visa is written on the visa) and after they arrive, they must go to the regional OIN office within 30 days to get their residence permit.

In case of rejection OIN must give reasons for the rejection, and you can appeal the negative decision. If OIN rejects your application again, you can turn to the court.

### **13. Where should my family members wait for the decision?**

Your family members can wait in the city of the Hungarian Consulate, or they can travel back to their country of origin and wait there. If your family members travelled to the Hungarian Consulate with the help of the ICRC, your family members should ask for help from the ICRC to take them back.

Your family members can also request help from UNHCR, IOM or the ICRC to give them shelter while they wait for the decision (either in the city of the Hungarian Consulate or in their home country). In some countries, for example, there are shelters for this purpose. Please keep in mind, however, that these organisations might not always be able to help.

OIN must decide within 21 days, but if any more documents are needed, the decision might take more time even months. In any case, your family should be prepared to spend about two months in another country if there is no Hungarian Consulate in the country where they are residing.

### **14. What travel documents are needed for travelling to Hungary?**

Your family member will need to have a national passport to travel to Hungary. Unfortunately, Somali travel documents were not accepted in the past years in Hungary, but the family members of Somalian persons should still try the options listed in Point 15. and A.2.

### **15. Who buys the plane tickets?**

You will have to pay for the plane tickets of your family members. You may wish to use an Internet based comparison site such as [www.skyscanner.net](http://www.skyscanner.net) to get the best price. You should also check return flights, because they might be cheaper than one-way flights ( even without using the return tickets), if you buy these.

### **16. What should my family members do after arriving in Hungary?**

After arrival in Hungary, your family members must go to the regional OIN office within 30 days to get their residence permit. They also have to register their address at the local OIN office.

Your family members can also ask for asylum, and OIN will most probably grant refugee status to you:

- Spouse;
- Minor children (including adopted or foster children);
- Parents (if you are under the age of 18 when your parents ask for asylum).

If you have subsidiary protection (*oltalmazott*) and your family members ask for asylum, OIN will not automatically grant them the same status that you have. OIN will require your family members to prove their cases.

If your family members do not ask for asylum they will have a residence permit and no other rights and entitlements (i.e. no integration contract and financial support).

**17. What happens if my family members cannot travel to the nearest Hungarian Consulate?**

They should ask for help from the ICRC.

**18. What should I do if I have lost contact with my family members?**

**19. Who can I ask for money if I cannot pay for plane tickets or other costs?**

Unfortunately, there are no organizations in Hungary which would pay for plane tickets. Usually, people borrow money from their friends or other people they know.

**20. Where can I request help, if the border police at the airport do not accept my family member's valid**

**passport or valid visa? What if my family has problems to leave the airport?**

You can ask the Hungarian Consulate which issued the visa to issue a certificate that there are no problems with the visa. You can also ask UNHCR to escort your family members to the airport to clear up any misunderstandings with the border police. You might want to buy a flexible ticket in case your family members are not able to leave the airport.

**21. Who can help me navigate this process?**

The Hungarian Helsinki Committee can help you navigate this process. Their contacts are on the back of this brochure.

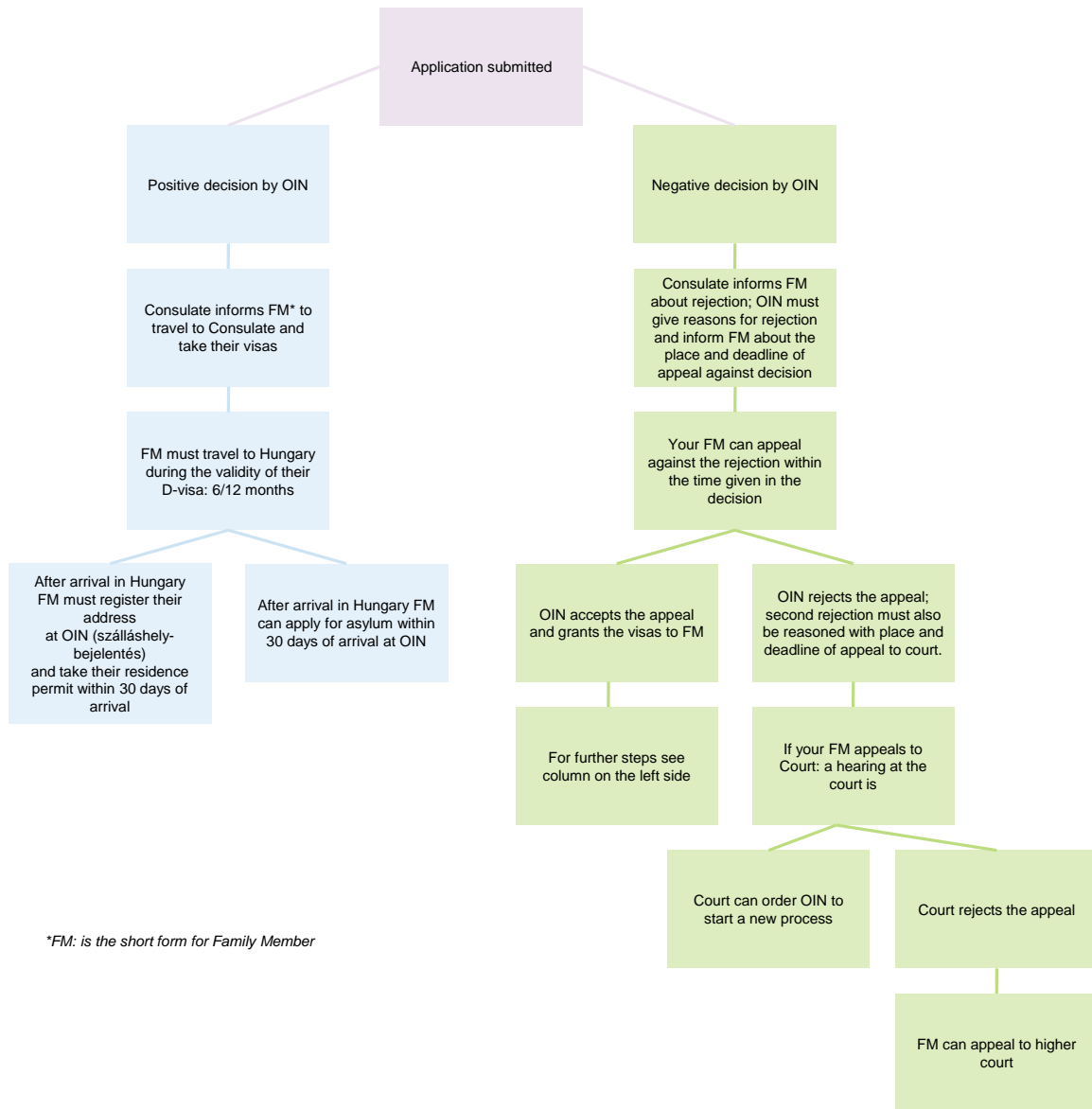
